Motion 23-094: Kevin King motioned to approve the minutes from 5/10/23 as presented. Cindi Vickers seconded with all voting yes. Motion Passed.

New Business:

- Canton Chair Rental submitted an option to do a 3-year contract. The contract is for items used during the fair. (This includes tables & chairs for the Art Hall and draping for the Exhibition Hall.)

Motion 23-096: Cindi Vickers motioned to make a 3-year contract with Canton Chair Rental for rental of draperies, tables, and chairs (etc....) for fairs 2023, 2024, 2025.

Discussion: Have we looked into other rental companies to compare pricing? *Motion Tabled until we receive more quotes.*

(The following motions are from discussions within that meeting.)

- **Motion 23-097:** Russ Thorn motioned to purchase 52 double roll toilet paper dispenser units for \$1,372.80. Travis Secrest seconded with all voting yes. Motion Passed.
- **Motion 23-098:** Russ Thorn motioned to contract with: OD Miller Electric Company to Install Poles and LED lights in the infield parking lot for \$52,200.00 / Contract with ANR Electric Company to install LED lighting in the North Parking Lot for \$8,500.00. Total for the projects is \$64,700.00. Ron Chambers seconded with 16 voting yes and 1 abstain. Motion Passed.
- **Motion 23-099:** Russ Thorn motioned to pay General RV for awning fabric and 3 hours of labor to repair damage that happened to the Yannayon family camper last fall on storage move-in night. The cost of the awning is \$642.99 + \$225.00/hr labor for 3 hours, for a total of \$1,410.00. Earl Rohn seconded with 16 voting yes and 1 abstain. Motion Passed.

Discussion: The storage contract states that all renters need to carry insurance and SCAS is not responsible for any damages. No further action will be taken after this payment.

- Water Line Project: A "Stop Order" was placed from the Canton Building Department. No work is to be done until this is resolved. The County Commissioners, Canton Water Department, Canton Building Department and Hammontree are working to address the "stop order".

Junior Fair:

- Scholarships need looked over.

Discussion: Do we give 2 - \$500 (one from SCAS and one from Charlie Swartz Memorial fund) or 1 - \$1000 (from Memorial Fund). Scholarship recipients need to be going into the agriculture field. Applications can be handed out now and Cindi Vickers will look into what amount we can do.

Motion 23-100: Earl Rohn motioned to purchase 3 banners advertising the fair dates from Kingsway Signs. The banners are to be placed along the fence. Total price is not to exceed \$450. Danny Schmucker seconded with 16 voting yes and 1 abstain. Motion Passed.

Motion 23-101: Danny Schmucker motioned to purchase yard signs that will display the fair dates. Total price is not to exceed \$500. Dave Swartz seconded with all voting yes. Motion Passed.

Motion 23-102: Jill Sterling motioned to hire 2 announcers for the fair at \$15.00 per hour, not to exceed \$1500. Cindi Vickers seconded with all voting yes. Motion Passed.

- Grandstand tickets sales for the concerts are going very well. We have sold 1,800 tickets so far for Styx.
- We are looking into the potential to save money by scanning tickets ourselves for the Truck & Tractor Pulls and the Demolition Derbies.
- Looking into what we can do with the Band Show for next year since it will be our 175th Fair.

Speed Committee:

- Hotel rooms need to be booked for Harness Racing during fair.
- The Horseman restrooms are not working. We need to provide something temporary while we wait for the Water line project to be completed.

Motion 23-103: Jill Sterling motioned to rent 1 Port-a-Jon until the water is restored in the Horseman bathrooms. Danny Schmucker seconded with all voting yes. Motion Passed.

- Charlie Myrick claims he overpaid for stalls last year. We gave him a credit of \$140, 4 months of one stall rent. [Motion 23-033 (February 8, 203 Minutes)] He claims he is still owed \$120.

Motion 23-104: Kevin King motioned to take \$120 off Charlie Myrick's next invoice. Travis Secrest seconded with 16 voting yes and 1 abstain. Motion Passed.

Motion 23-107: Jill McNeil motioned to order pens for the goat barn, not to exceed \$15,000. Cindi Vickers seconded with all voting yes.
